3. Review and Accept Minutes of the August 27, 2024, Board Meeting:

- <u>Director's Report:</u> Michelle reported there was a visit from goats, and human volunteers, to help clear brush along the parking lot and Cemetery border. Inter Library Loan is running again although it was off to a rough start due to backlogs and the new company having to work out some issues with vehicles and drivers.
- Strategic Planning Committee 9/4/24 & 9/18/24: Michelle announced the final review of the Strategic Plan by the Committees will be at their October meetings. An Open House to announce the new plan and to thank the community for their participation will be November 19 from 4-6pm. Copies of the Strategic Plan will be available.

Peg will focus on book sales. Michelle will send a note of thanks to Peg for her great service as liaison.

<u>Development:</u> Anita reports:

- A. Worthy Wednesday at the Burleigh On December 11, 10% of the restaurant's profits will be donated to KFL. The link for reservations is live. Tell your friends and family.
- B. December 13 is KFL volunteer night for Fire and Ice at the Nonantum. From about 5:15 to 9 or 10 pm the Library will provide 10 volunteers for the event in exchange for a grant of \$5000. Five, maybe six, people have signed up so 4-5 more are needed. Suggestions were made for who might be willing, and Anita asked for any additional names be given her. The question of parking that night was discussed.
 - C. Holiday Giving Campaign, which was started two years ago, added a Trustee Match along with the Cole Harrison match last year. Anita would like to do this again and

asked if, as a group, the Trustees could pledge \$2500. This is totally voluntary and up to each trustee how much and when they choose to donate, to Holiday Giving or to the Annual Appeal, although Anita would like to concentrate on the Holiday Giving. More than \$41,000 was raised last year. Michelle has set the goal at \$50,000 for this year. A match of \$5000 lowers that goal to \$45,000, a match of \$10,000 to \$40,000 etc. Anita is broadening the ask to other major donors and hopes to grow beyond the \$5000 match although there are no hard commitments yet.
